**CALL FOR SUBMISSION OF APPLICATIONS
FOR THE UNION ACTION “EUROPEAN CAPITAL OF CULTURE”
FOR THE YEAR 2022 IN THE REPUBLIC OF LITHUANIA**

**CHAPTER I
GENERAL PROVISIONS**

1. Throughout history, Europe has been a hub of artistic development of exceptional richness and great diversity where European cities have played a vital role in the formation and spread of culture.

2. The European Capital of Culture action is an initiative of the European Union which aims at highlighting this richness and diversity as well as common cultural aspects in Europe with a view to contributing to bring the peoples of Europe closer together and improve mutual understanding.

Against this backdrop, the general objectives of the European Capital of Culture action have been defined as follows: to safeguard and promote the diversity of cultures in Europe and to highlight the common features they share as well as to increase citizens' sense of belonging to a common cultural area, on the one hand, and to foster the contribution of culture to the long-term development of cities in accordance with their respective strategies and priorities, on the other hand.

In line with these objectives, activities developed by the city that will be designated as European Capital of Culture will strive to enhance the range, diversity and European dimension of its cultural offering, including through transnational co-operation; to widen access to and participation in culture; to strengthen the capacity of its cultural sector and the links of the latter with other sectors and to raise its international profile through culture.

3. The title of European Capital of Culture shall be awarded each year to a maximum of one city in each of the two Member States appearing in the calendar set out in the Annex of Decision No 445/2014/EU of the European Parliament and of the Council of 16 April 2014 establishing a Union action for the European Capitals of Culture for the years 2020 to 2033 and repealing Decision No 1622/2006/EC (OJ 2014 L 132, p. 1) (hereinafter referred to as “the Decision No 445/2014/EU”). For the year 2022, the two Member States entitled to host the European Capital of Culture action are Lithuania and Luxembourg.

4. The aim of the call for submission of applications for the Union action “European Capital of Culture” for the year 2022 in the Republic of Lithuania (hereinafter referred to as “the call”) is to trigger applications from cities in Lithuania wishing to bid for the “European Capital of Culture” title for the year 2022 and to lead to the designation of one of these cities that may be awarded the Melina Mercouri prize.

5. To assist cities in the preparation of their bid, the call provides an overview of the criteria that will be applied for the assessment of their applications as well as information about the selection procedure. In annex 1, cities will also find the application form they have to complete in order to submit an application.

6. The call is based on Decision No 445/2014/EU, which specifies in particular the criteria to be used.

7. The Melina Mercouri prize is funded from Regulation (EU) No 1295/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Creative Europe Programme (2014 to 2020) and repealing Decisions No 1718/2006/EC, No 1855/2006/EC and No 1041/2009/EC (OJ 2013 L 347, p. 221) (hereinafter referred to as “the EU programme “Creative Europe”).

8. The Ministry of Culture of the Republic of Lithuania (hereinafter referred to as “the Ministry of Culture”) is the Managing Authority which is in charge of the selection procedure for the European Capital of Culture title for the year 2022 in Lithuania.

CHAPTER II OUTCOME OF THE SELECTION PROCESS

10. The outcome of the selection process of the European Capital of Culture Union action is twofold:

10.1. The award of the title of European Capital of Culture;

10.2. The award of a pecuniary prize of 1.5 M€ in honour of Melina Mercouri.

11. To that extent, this call is also to be seen as the rules of the contest for the awarding of the Melina Mercouri prize.

12. While the title and the prize are awarded the same year on the basis of the same criteria detailed in Chapter 3 of this call, the payment of the prize occurs in the course of the title-year and is conditioned and ruled by the requirements laid down in Chapter 6 of this call.

CHAPTER III CRITERIA FOR DESIGNATING A CITY FOR THE TITLE OF EUROPEAN CAPITAL OF CULTURE AND AWARDING THE MELINA MERCOURI PRIZE

FIRST SECTION ELIGIBILITY CRITERIA

Eligible applicants

13. This call is exclusively addressed to the cities of Lithuania which wish to apply for the title of European Capital of Culture 2022.

14. The title applies to a city. Cities may involve their surrounding areas if they wish so, but the title is awarded only to the city itself and not to the whole area. Therefore, where a city involves its surrounding area, the application shall be made under the name of the city.

15. Every application must be based on a cultural programme with a strong European dimension. The cultural programme shall cover the year of the European Capital of Culture title and shall be created specifically for the title.

16. In case of claim relating to the activities carried out in the framework of the submission for applications, the sole liability of applicants can be invoked.

Formal criteria of the application

17. All candidate cities shall fill in the common application form laid down in annex 1.

18. Candidate cities are invited to comply with the following formal requirements when drafting their application. Applications which do not follow these requirements at pre-selection or final selection stages (more details about selection stages are provided in Chapter 4 of this call) will be considered ineligible and not examined further:

18.1. The application shall be written in English and Lithuanian languages. Both versions must be identical from content and presentation points of view. The English version of the applications will be the working version for the panel established to carry out the selection procedure;

18.2. Candidate cities shall answer all the questions, with the exception – at pre-selection stage – of those questions that are indicated as optional;

18.3. For the pre-selection stage, the English version of the applications shall not exceed 80 pages in A4 format. For the final selection stage, the English version of the application shall not exceed 100 pages in A4 format. Applicants may include illustrations, graphics or any other visual elements (such as logos), but these are included as part of the page limit;

18.4. For the pre-selection stage, applications shall be sent in paper and electronic formats within the deadline indicated under Chapter 5 “Submission of applications”. For the final selection stage, applications shall be sent in paper and electronic formats within the deadline that will be indicated by the Ministry of Culture to the shortlisted cities after completion of the pre-selection stage.

SECOND SECTION EXCLUSION CRITERIA

19. Candidate cities must sign a declaration on their honour (in English and Lithuanian languages) certifying that they are not in one of the situations referred to in Article 106(1) and Articles 107, 108 and 109 of Regulation (EU, EURATOM) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union (OJ 2012 L 298, p. 1) (hereinafter referred to as “the EU Financial Regulation”), filling in the relevant form attached in annex 2.

THIRD SECTION AWARD CRITERIA

20. The award criteria for the assessment of the applications are divided into six categories corresponding to the provisions laid down in Article 5 of Decision No 445/2014/EU and all six categories have the same weighting:

- 20.1. Contribution to the long-term strategy;
- 20.2. European dimension;
- 20.3. Cultural and artistic content;
- 20.4. Capacity to deliver;
- 20.5. Outreach;
- 20.6. Management.

21. As regards the “contribution to the long-term strategy”, the following factors shall be taken into account:

21.1. that a cultural strategy for the candidate city, which covers the action and includes plans for sustaining the cultural activities beyond the year of the title, is in place at the time of its application;

21.2. the plans to strengthen the capacity of the cultural and creative sectors, including developing long-term links between the cultural, economic and social sectors in the candidate city;

21.3. the envisaged long-term cultural, social and economic impact, including urban development, that the title would have on the candidate city;

21.4. the plans for monitoring and evaluating the impact of the title on the candidate city and for disseminating the results of the evaluation.

22. As regards the “European dimension”, the following factors shall be taken into account:

22.1. the scope and quality of activities promoting the cultural diversity of Europe, intercultural dialogue and greater mutual understanding between European citizens;

22.2. the scope and quality of activities highlighting the common aspects of European cultures, heritage and history, as well as European integration and current European themes;

22.3. the scope and quality of activities featuring European artists, cooperation with operators or cities in different countries, including, where appropriate, other cities holding the title, and transnational partnerships;

- 22.4. the strategy to attract the interest of a broad European and international public.
23. As regards the “cultural and artistic content”, the following factors shall be taken into account:
- 23.1. a clear and coherent artistic vision and strategy for the cultural programme;
- 23.2. the involvement of local artists and cultural organisations in the conception and implementation of the cultural programme;
- 23.3. the range and diversity of the activities proposed and their overall artistic quality;
- 23.4. the capacity to combine local cultural heritage and traditional art forms with new, innovative and experimental cultural expressions.
24. As regards the “capacity to deliver”, the following factors shall be taken into account:
- 24.1. the application has broad and strong political support and a sustainable commitment from the local, regional and national authorities;
- 24.2. the candidate city has or will have an adequate and viable infrastructure to hold the title.
25. As regards “outreach”, the following factors shall be taken into account:
- 25.1. the involvement of the local population and civil society in the preparation of the application and the implementation of the action;
- 25.2. the creation of new and sustainable opportunities for a wide range of citizens to attend or participate in cultural activities, in particular young people, volunteers and the marginalised and disadvantaged, including minorities, with special attention being given to persons with disabilities and the elderly as regards the accessibility of those activities;
- 25.3. the overall strategy for audience development, and in particular the link with education and the participation of schools.
26. As regards “management”, the following factors shall be taken into account:
- 26.1. the feasibility of the fund-raising strategy and proposed budget, which includes, where appropriate, plans to seek financial support from Union programmes and funds, and covers the preparation phase, the year of the title, the evaluation and provisions for the legacy activities, and contingency planning;
- 26.2. the envisaged governance and delivery structure for the implementation of the action which provides, inter alia, for appropriate cooperation between the local authorities and the delivery structure, including the artistic team;
- 26.3. the procedures for the appointment of the general and artistic directors and their fields of action;
- 26.4. the marketing and communication strategy is comprehensive and highlights that the action is a Union action;
- 26.5. the delivery structure has staff with appropriate skills and experience to plan, manage and deliver the cultural programme for the year of the title.
27. These criteria are explained and illustrated by examples in the Guide for candidate cities, which is available on the websites of the Ministry of Culture and the Directorate-General for Education and Culture of the European Commission at the following addresses: www.lrkm.lt and http://ec.europa.eu/programmes/creative-europe/actions/capitals-culture_en.htm.

CHAPTER IV

PROCEDURE FOR THE DESIGNATION OF ONE CITY AS EUROPEAN CAPITAL OF CULTURE AND THE AWARD OF THE MELINA MERCOURI PRIZE

FIRST SECTION

THE PANEL OF EXPERTS

28. A panel of independent experts (hereinafter referred to as “the panel”) shall be established to carry out the selection and monitoring procedures.

29. The role of the panel is to assess the applications received from candidate cities, agree on a list of pre-selected cities as well as recommend one city for being awarded with the title of European Capital of Culture and the Melina Mercouri prize. At the end of the monitoring phase

(more details about this phase are provided in Chapter 6 of this call), it is also the role of the panel to issue a report which will be the basis for the European Commission's decision to pay or not the Melina Mercury prize to the city.

30. The panel will consist of 10 to 12 members.

31. For the purpose of the pre-selection and selection stages, 10 members will be experts appointed by the European institutions and bodies (European Parliament, Council, Commission and Committee of the Regions). The Minister of Culture of the Republic of Lithuania, in consultation with the European Commission, will be entitled to appoint up to 2 members to the panel.

32. The same experts shall be appointed by the authorising officer of the Commission so as to give a recommendation about the award of the Melina Mercouri prize.

33. In accordance with Article 6 of Decision No 445/2014/EU, the experts shall be citizens of the Union, shall be independent, have no actual or potential conflict of interest in respect of a specific candidate city and have substantial experience and expertise in the cultural sector, in the cultural development of cities or in the organisation of a European Capital of Culture or an international cultural event of similar scope and scale.

SECOND SECTION PHASES OF THE PROCEDURE

34. The procedure for designating one city as European Capital of Culture is broken down to the selection phase and the designation of the city as European Capital of Culture and the award of the Melina Mercouri prize.

35. The selection phase is made of 2 different stages: pre-selection and final selection stage.

Pre-selection stage

36. The Ministry of Culture will organise a pre-selection meeting on a date that will be specified later on the Ministry's website (at least 5 years before the year of the title) inviting all candidate cities which have submitted an application in response to this call in the deadline set in Chapter 5 "Submission of applications", to send a delegation for a hearing with the panel.

37. The panel shall assess each candidate city on the basis of its application and hearing against the objectives of the European Capital of Culture action and the criteria as specified above.

38. After this meeting, the panel will agree on a shortlist of candidate cities which shall be invited to complete and revise their applications during the final selection stage. The Panel shall issue a pre-selection report containing a general assessment of all the applications, the short-list of candidate cities which are to be considered further as well as recommendations to these cities.

39. The Ministry of Culture shall then formally approve the short-list based on the report of the panel and shall send a letter to short-listed candidate cities inviting them to complete and revise their applications and indicating the deadline for submitting such applications.

Final selection stage

40. The short-listed candidate cities will complete and revise their applications with a view to complying with the award criteria as well as taking into account the recommendations contained in the pre-selection report. Each pre-selected city will send its revised application to the Ministry of Culture in due time.

41. At this stage, the panel may wish to pay a visit to the pre-selected cities to get *in situ* a better understanding of the candidacies as well as the level of ownership among the city's inhabitants and key stakeholders.

42. In any case, the Ministry of Culture will organise a selection meeting on a date to be specified later on the Ministry's website (preferably no later than 9 months after the pre-selection meeting) inviting all short-listed cities to send a delegation for a hearing with the panel.

43. The panel shall assess each short-listed candidate city on the basis of its revised application and hearing against the objectives of the European Capital of Culture action and the criteria as specified above.

44. After this meeting, the panel shall agree on the recommendation of a maximum of one city for the title. If none of the candidate cities fulfil all the criteria, the panel may recommend not to award the title in Lithuania in 2022.

45. The panel shall issue a selection report containing a general assessment of all the applications and a justified recommendation for the designation of one city for the title. The report shall also contain recommendations to the city concerned regarding the progress to be made by the year of the title.

The designation of the city as European Capital of Culture and the award of the Melina Mercouri prize

46. The Ministry of Culture shall, based on the recommendation of the panel, designate one city to hold the title for the 2022 European Capital of Culture and shall notify the European Parliament, the Council, the Commission and the Committee of the Regions of that designation no later than 4 years before the title-year.

47. At the same time it recommends a city for the title, the panel will also recommend the authorising officer of the European Commission to award the Melina Mercouri prize to this city.

48. Once the city has been officially designated, the authorising officer of the European Commission, upon this recommendation, may award it the Melina Mercouri prize which amounts to € 1.500.000 (subject to the funding being made available under the EU Programme “Creative Europe”).

CHAPTER V SUBMISSION OF APPLICATIONS

49. The cities of Lithuania wishing to apply for the European Capital of Culture title in 2022 shall reply to this call by filling in the application form in annex 1 as well as the “declaration of honour” form in annex 2.

50. The application form is the same for the pre-selection stage and the final selection stage except questions which are deemed as being optional at the pre-selection stage.

51. 20 paper copies in English language, 1 paper copy in Lithuanian language and 1 electronic version in English and Lithuanian languages of each application must be sent to the following postal address and e-mail address no later than **24 May 2016**:

52. Applicants will be informed by Ministry of Culture of the receipt of their application within 10 working days.

53. By submitting an application, cities accept that their e-application at both pre-selection and selection stages be made public on www.lrkm.lt and http://ec.europa.eu/programmes/creative-europe/actions/capitals-culture_en.htm at the end of the selection phase.

54. For formal requirements for the application please refer to Chapter 3 under First Section of this call.

CHAPTER VI MONITORING AND PAYMENT OF THE MELINA MERCOURI PRIZE

55. While the prize is awarded at the moment of the designation, its payment will occur no later than the end of March 2022 provided that the city designated continues to honour the commitments it made at the application stage, still complies with the award criteria of the action and takes into account the recommendations contained in the selection and monitoring reports of the panel.

56. The commitments made at the application stage shall be deemed to have been honoured by the designated city where no substantial change has been made to the programme and the strategy between the application stage and the year of the title, in particular where:

56.1. the budget has been maintained at a level capable of delivering a high-quality cultural programme in line with the application and the criteria;

56.2. the independence of the artistic team has been appropriately respected;

56.3. the European dimension has remained sufficiently strong in the final version of the cultural programme;

56.4. the marketing and communication strategy and the communication material used by the designated city clearly reflect the fact that the European Capitals of Culture is an action of the Union;

56.5. the plans for the monitoring and evaluation of the impact of the title on the city are in place.

57. Compliance with these requirements will be assessed by the European Commission on the basis of a recommendation made by a panel of independent experts at the end of the monitoring phase, which runs from the designation of the city as European Capital of Culture up to the beginning of the year of the title.

58. Similarly to the selection process, the monitoring phase is carried out by the panel. The European Commission will convene 3 monitoring meetings between the panel and the designated city in order for the panel to take stock of the preparations for the event and give advice with a view to helping the city to develop a high-quality cultural programme and an effective strategy. After the 3rd meeting, the panel will issue a report which will be the basis for the European Commission's decision to pay or not the Melina Mercouri prize to the city. The payment of the prize is therefore not automatic.

59. Once the authorising officer of the European Commission has issued the decision regarding the award of the prize, the city accepts that checks and audits by the European Commission, the European Anti-Fraud Office (OLAF) and the Court of Auditors can be carried out.

60. Regarding the award and payment of the prize, the Law of the Union applies. The competent court or arbitration tribunal to hear disputes is the General Court of the Court of Justice of the European Union:

61. Financial or administrative penalties, or both, may be imposed on applicants who have made false declarations, or committed irregularities or fraud, in accordance with the conditions laid down in Article 145 of the EU Financial Regulation and in proportion to the value of the Melina Mercouri prize.

62. Once the title year ends, the city awarded the title of European Capital of Culture will have to produce an evaluation report using the common guidelines and indicators established by the European Commission (available on www.lrkmlt and http://ec.europa.eu/programmes/creative-europe/actions/documents/ecoc/city-own-guide_en.pdf) and transmit it to the European Commission by **31 December of 2023** in accordance with Article 16 of Decision No 445/2014/EU.

CHAPTER VII FINAL PROVISIONS

63. Cities interested in the title may obtain information at the information meeting to be organised on **21 September 2015** in Vilnius by the Ministry of Culture and the European Commission (place and exact time will be specified later on the website of the Ministry of Culture).

All the questions and related responses must appear clearly in the application and the order of the questions must be respected both at pre-selection and final selection stages.

Candidate cities are also invited to be concise and sharp in their answers. Furthermore great care should be given to ensure maximum readability of the applications.

Introduction – General considerations

- Why does your city wish to take part in the competition for the title of European Capital of Culture?
- Does your city plan to involve its surrounding area? Explain this choice.
- Explain briefly the overall cultural profile of your city.
- Explain the concept of the programme which would be launched if the city is designated as European Capital of Culture.

1. Contribution to the long-term strategy

- Describe the cultural strategy that is in place in your city at the time of the application, as well as the city's plans to strengthen the capacity of the cultural and creative sectors, including through the development of long term links between these sectors and the economic and social sectors in your city. What are the plans for sustaining the cultural activities beyond the year of the title?
- How is the European Capital of Culture action included in this strategy?
- If your city is awarded the title of European Capital of Culture, what do you think would be the long-term cultural, social and economic impact on the city (including in terms of urban development)?
- Describe your plans for monitoring and evaluating the impact of the title on your city and for disseminating the results of the evaluation. In particular, the following questions could be considered:
 - Who will carry out the evaluation?
 - Will concrete objectives and milestones between the designation and the year of the title be included in your evaluation plan?
 - What baseline studies or surveys - if any - will you intend to use?

- What sort of information will you track and monitor?
- How will you define “success”?
- Over what time frame and how regularly will the evaluation be carried out?

(Date and place / project partners / financing are optional at pre-selection stage).
- How will the events and activities that will constitute the cultural programme for the year be chosen?
(This question is optional at pre-selection stage).
- How will the cultural programme combine local cultural heritage and traditional art forms with new, innovative and experimental cultural expressions?

- How has the city involved, or how does it plan to involve, local artists and cultural organisations in the conception and implementation of the cultural programme?
Please give some concrete examples and name some local artists and cultural organisations with which cooperation is envisaged and specify the type of exchanges in question.

4. Capacity to deliver

- Please confirm and supply evidence that you have broad and strong political support and a sustainable commitment from the relevant local, regional and national public authorities.
- Please confirm and evidence that your city has or will have adequate and viable infrastructure to host the title. To do that, please answer the following questions:
 - Explain briefly how the European Capital of Culture will make use of and develop the city's cultural infrastructure.
 - What are the city's assets in terms of accessibility (regional, national and international transport)?
